CONTRACT

For cooperation with TV BTR SAT and TV BTR Nacional

- 1. TV BTR SAT oblige to present all video presentations no matter if they are music, informative, educative, documentary or serial depending of the contract with the contractor.
- 2. TV BTR keep the right to reject emitting of show (fun, educative, informative, documentary, and other forms) or campaign message if it is guided to ruining of the constitutive order or it invoke military aggression and development of racist or religious hate, or if in it is performed abuse of children for various purpose.
- 3. The contractor should choose for which option from the first point of the contract will accept.
- 4. The contractor is obliged to send the video material in time and should arrive in TV BTR SAT at least three days before emitting.
- 5. TV BTR SAT does not take the postal expenses, but the contractor who send the mail.
- 6. The contract duration is:
